LITTER REMOVAL AGREEMENT**

- I. The SPONSOR agrees to the following:
- A. Be responsible for a minimum of a two-mile segment of a road for litter removal or if a road is less than 2 miles long it can be adopted but the road has to be at least a minimum of a mile long.
  - B. Remove the litter from along the right of way of the adopted road segment no less than four times per year (quarterly) MINIMUM.
  - C. Remove litter during daylight hours and good weather conditions only.
  - D. Do not remove litter at designated construction sites, or on bridges or overpasses.
  - E. Allow only such persons to participate as are determined by the SPONSOR to be responsible enough to safely participate in the litter removal activities. (Participating youths must be at least 12 years of age and the SPONSOR shall provide at least one (1) adult supervisor for every five (5) youths aged 12 - 15, who are participating in the litter removal activity.)
  - F. If more than five (5) trash bags are collected, leave filled trash bags at the Adopt-A-Road signs and notify Jefferson County Solid Waste to schedule collection.
  - G. Complete and submit a Litter Removal Report form for each clean-up activity.

II. The SPONSOR agrees that it will indemnify, hold harmless and defend Jefferson County and all its officials, agents and employees from any claim, loss, damage, or expense arising out of any act of neglect or omission by the SPONSOR, or by any of its participants, or members during the performance of this AGREEMENT, or to any individuals, participants, or associates of the SPONSOR. The SPONSOR shall indemnify and hold harmless Jefferson County against any claims, damages, liabilities, losses and costs, including, but not limited to, reasonable attorneys' fees incurred by JEFFERSON COUNTY in effecting such defense. The liability of JEFFERSON COUNTY, if any, is strictly limited in accordance with Section 768.28, Florida Statutes.

III. The DEPARTMENT agrees to provide the GROUP with safety vests, pickup sticks and trash bags for the litter removal event.

IV. This AGREEMENT shall remain in effect for a two (2) year period, beginning on the date first written below, and can be renewed upon written request. Either Jefferson County or the SPONSOR may terminate this AGREEMENT for any reason upon 30 days written notice to the other parties.

I certify that I am familiar with the information contained in this AGREEMENT and that I possess the full authority to execute this AGREEMENT on behalf of the SPONSOR.
